Who Signs A Board Resolution

Like every legal document, resolutions need to be signed and dated by the members of the board as they would do with minutes of meetings. When a resolution involves any legal technicalities, they have to be first drafted and looked over by legal counsel before they are given to the president of the

organization for review and then to other members of the board during the meeting.

It is a general practice that the Board of Directors in its meeting, while passing a resolution on any item of business, authorise any Director or Employee or Officer of the company to sign and issue the certified true copy of the board resolution. The following additional resolution is added to the main resolution (s) for this purpose.

As per Sec.21 of Companies Act 2013, resolution can be signed by any Key Managerial Personnel (which includes a Managing Director) or an officer of the company duly authorized by the Board. Hence there is nothing illegal, if the resolution is signed by Managing Director.Provisions of the Companies Act, 2013: Section 21: Authentication of documents, proceedings and contracts.

A corporate resolution is a formal declaration made by a board of directors that officially records specific decisions that are material to a business.
