The AIA used to make a limited scope Cost of the Work agreement called A117-1987 Edition but it is no longer for sale but I still use it when a contractor is unfamiliar with some of the more esoteric language of the newer AIA documents. All AIA forms require crossing out references to an architect if one is not used to administrate the agreement. The agreements do assume that the owner has supplied the builder with a set of design documents. If the builder designs the building it is ...
