A little over a year ago the United Nations Convention on Contracts for the International Carriage of Goods Wholly or Partly by Sea (Rotterdam Rules) were implemented near the end of 2009 with a view to both modernising and harmonising the law as it relates to the international carriage of goods by sea through the replacement of Conventions relating to liability that were already in existence.

The International Conventions on Carriage of Goods

As used in the Convention, 'international carriage' refers to carriage governed by the Convention (Convention carriage), that is, carriage of which, according to the contract, the initial point of departure and the final destination are in two contracting States to the Convention, or in the same contracting State if there is an agreed stopping place in any foreign country.

Law of Carriage of Goods

It constitutes a major step toward international unification of the rules governing carriage of goods by air. The convention applies to international carriage of persons, luggage, and goods for reward, as well as to gratuitous carriage performed by an air-transport undertaking. It applies whether the aircraft is owned by private persons or by public bodies; but, as to aircraft owned by a state directly, application of the convention may be excluded by appropriate reservation.
