Resolutions which are passed in a meeting should be accurately recorded in the minutes of the meeting. Minutes serve as evidence of meeting proceedings and must be kept at the company's registered office or Single Alternative Inspection Location (SAIL) for at least 10 years.

Company resolution - Ordinary and special resolution

Shareholders Resolutions are used in order to record official acts agreed to by corporate shareholders. These resolutions can be taken with or without a meeting and should be carefully recorded. A Shareholders Resolution becomes an official part of the corporate record.

A company resolution is passed by shareholders. Typically, shareholders are not part of day-to-day operations of the company. Rather, shareholders are involved in matters about the company shares.

In extreme situations, especially where illegal activity is alleged to have occurred, a common legal resolution to shareholder disputes is to remove the company's director from the board. But to do so, it takes a vote of more than 50% of the shareholders in attendance at a shareholder's meeting.

7 Common Legal Resolutions for any Shareholder Dispute

Bank Account: The minutes record the name of the branch and bank where the

corporate funds will be deposited. The director authorizes the officers to open the corporate account and deposit funds. Shares: The names of shareholders, the number of shares they hold, and the money or property they exchanged for their shares is recorded.

Special and Ordinary Shareholders' Resolutions

As mentioned above, shareholders representing at least 5% of the company's voting rights can require the board to call a general meeting of the shareholders to consider a resolution to dismiss a director. To be effective, the resolution must be passed at the meeting by more than 50% of the votes cast.

With respect to public companies in the United States, a shareholder resolution is a proposal submitted by shareholders for a vote at the company's annual meeting. Typically, resolutions are opposed by the corporation's management, hence the insistence for a vote. "Voting has long been recognized as one of the primary rights of shareholders."
