To find out if their benefits are taxable, taxpayers should: Take one half of the Social Security money they collected during the year and add it to their other income. Other income includes pensions, wages, interest, dividends and capital gains. You would pay taxes on 85 percent of your \$18,000 in annual benefits, or \$15,300. Nobody pays taxes on more than 85 percent of their Social Security benefits, no matter their income. For purposes of determining how the Internal Revenue Service treats your Social Security payments, “income” means your adjusted gross income plus nontaxable interest income plus half of your Social Security benefits.

For married couples filing jointly with a combined income exceeding \$44,000, they are required to pay income taxes on up to 85 percent of their Social Security benefits. The Social Security tax rate is 6.2 percent for an employer and 6.2 percent for an employee, or 12.4 percent total.
