THE DANGEROUS DRUGS ACT - Ministry of Justice

The legislation was widened to criminalise civilian possession of those drugs without a medical need. The 1920 Dangerous Drugs Act incorporated the provisions made under the Defence of the Realm Act regulations. The Act established that medical practitioners were allowed to prescribe morphine, cocaine and heroin.

In the United Kingdom the Dangerous Drugs Act 1920 is an Act which changed to a penal offence drug addiction which up to then was, within the medical profession, treated as a disease.
