Section 112 of the Evidence Act provides for the legal presumption as to the legitimacy of the child born during the subsistence of a valid marriage or within a certain period after the dissolution of the marriage provided the mother of the child does not remarry. This section is based on the English rule that a child born out of the wedlock should be treated as the child of the man who was, at the time of the birth of the child, the husband of its mother.
