Your manual payroll calculations are based on the pay frequency and their hourly wage. So, for someone who is full time making \$11 an hour on a biweekly pay schedule, the calculation would look like this: 40 hours x 2 weeks = 80 hours x \$11/hour = \$880 (gross regular pay). Manual calculation of Week 1 tax Week 1 (/ month 1) tax is non-cumulative and calculates on a period-by-period basis. This means that all calculations are based purely on taxable payments the employee receives in the current period only.
