The terms are typically in short form, and will be spelled out in greater detail in the Fund’s Limited Partnership Agreement and Private Placement Memorandum (PPM).

The term sheet is usually a non-binding agreement that contains all the essential points related to the investment like capitalization and valuation, stake to be acquired, conversion rights, asset sale, etc. Private equity identifies a target company, goes through the business model, studies the business plan, performs due diligence, and then does the necessary discussions & negotiations before deciding on the target company.
