Written resolution of board of directors | Practical Law

The Companies Act 2006 provides that a written resolution can be signed by the same majority as a resolution passed at a meeting, which is a simple majority for an ordinary resolution and 75% for a special resolution, whereas under the 1985 Act unanimity was required. However note that the written resolution procedure cannot be used to remove a director or an auditor from office.

Special and Ordinary Shareholders' Resolutions

After any resolution is made during a Board meeting, a Board meeting resolution document is typically prepared to detail-out specifics of the resolution. A Board Resolution is a legally binding document for your company and you should keep it with company records for future reference of decisions made by your Board of Directors.

A resolution may be proposed as a written one by the directors or by the members. The company must send the proposed resolution to every eligible member either in hard copy form, in electronic form or by means of a website. The requirements as to notice and so on, are the same as for a physical meeting.

Written resolutions give the directors greater flexibility in making decisions, as the directors don't have to be present at a board meeting. Directors' decisions made by written resolution must be unanimous. This means that all eligible directors, i.e. those entitled to vote, must vote for the same view on a matter. Sometimes a director isn't allowed to vote on a matter, i.e. they aren't an ...
