required minimum distribution (rmd) form The Internal Revenue Service (IRS) requires that you begin receiving distributions from your Individual Retirement Account (IRA) by your required beginning date (April 1, following the year in which you become age 70 ½) and December 31 each year thereafter.

REQUIRED MINIMUM DISTRIBUTION (RMD) FORM

IRA owners must begin taking distributions (“Required Minimum Distributions”) from their traditional (non-Roth) IRAs from . age 70½ to age 72. The change applies to IRA owners who attain age 70½ as of January 1, 2020 or later. IRS regulations require that when you reach 72, you must receive a minimum amount from your IRA account(s) by

Required Minimum Distribution (RMD) Definition

Required Minimum Distribution Authorization For Required Minimum Distributions (RMDs) generally are minimum amounts that a retirement plan account owner must withdraw annually starting with the year that he or she reaches 70 ½ years of age or, if later, the year in which he or she retires.

If you currently receive Required Minimum Distribution (“RMD”) payments and you do not want to make any changes to the amount or payment schedule, or if you have already satisfied your annual RMD, you DO NOT need to complete or return this form. Note: If you were born on or after July 1, 1949 RMD Distribution age will be age 72 not 70½.

MFS IRA DISTRIBUTION AUTHORIZATION FORM

Your withdrawals will be included in your taxable income except for any part that was taxed before (your basis) or that can be received tax-free (such as qualified distributions from designated Roth accounts).

Your required minimum distribution is the minimum amount you must withdraw from your account each year. You generally have to start taking withdrawals from your IRA, SEP IRA, SIMPLE IRA, or retirement plan account when you reach age 72 (70 ½ if you reach 70 ½ before January 1, 2020).
