Workers' compensation is insurance that provides cash benefits and/or medical care for workers who are injured or become ill as a direct result of their job. Employers pay for this insurance, and shall not require the employee to contribute to the cost of compensation.

Workers' compensation law is a system of rules in every state designed to pay the expenses of employees who are harmed while performing job-related duties. Employees can recover lost wages, medical expenses, disability payments, and costs associated with rehabilitation and retraining.

Workers' compensation or workers' comp (formerly workmen's compensation until the name was changed to make it gender-neutral) is a form of insurance providing wage replacement and medical benefits to employees injured in the course of employment in exchange for mandatory relinquishment of the employee's right to sue his or her employer for the tort of negligence.

Workers' compensation laws are governed by each state legislation and by federal statutes. Both provide for fixed awards to employees or their dependents in the event of employment-related accidents and diseases.

This law, originally enacted in 1911, requires employers to provide no fault workers' compensation insurance coverage for employees in case of accidental injury, death of occupational disease, arising out of and in the course of employment.

"Workers' compensation" refers to a form of employer insurance that is meant to provide injured employees with compensation for work-related injuries. Every state has its own workers' compensation laws. Virginia has the Virginia Workers' Compensation Act that requires most employers to carry workers' compensation insurance.
