After sifting through mountains of data and thousands of pages of interviews, Collins and his crew discovered the key determinants of greatness -- why some

The findings include: Level 5 Leaders: The research team was shocked to discover the type of leadership required to achieve greatness. Technology Accelerators: Good-to-great companies think differently about the role of technology.
