INTRODUCTION.

Agencies have the responsibility to collect on delinquent accounts in accordance with Management Directive 310.10. Once an agency exhausts all local collection efforts and has satisfied the three Dunning Letter requirement in MD310.10, the agency is authorized to refer their delinquent accounts to the Collections Unit under the Comptroller of the Pennsylvania Office of Attorney General (hereinafter referred as OAG).
