A contract gives both you and your employer certain rights and obligations. The most common example is that you have a right to be paid for the work you do. Your employer has a right to give reasonable instructions to you and for you to work at your job. These rights and obligations are called 'contractual terms'.

By law, an employer must provide anyone who's classed as an employee with the terms of their employment in writing (a 'written statement of employment particulars'). This document must

contain a summary of the main terms of employment, such as pay and working hours. This document is often referred to as the 'employment contract'.
