A board resolution (bank employees will

often call it “BR”) is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP).

The copy of the board resolution has to be printed on the letterhead of the company and signed by the duly authorised director (s)/ officer (s) of the company, with the rubber stamp/seal of the company on it. Board Resolution for a Bank Loan A company's Board of Directors must pass a resolution if the company needs to apply for a bank loan. In addition to approving this loan, the resolution may also approve mortgaging the company property if the loan requires some form of collateral.

Board Resolution Format for Opening a New Bank Account A certified copy of the board resolution, regarding the approval of the opening of a new bank account in the name of the company,

needs to be provided to the bank where the company wants to open the account. Additionally, the company will have to submit other documents as well.

Board Resolution Format for Opening a New Bank Account

In case a company is maintaining a current account with any bank and it becomes non-operational or for any other reasons - the management deems it fit to close the account, then a resolution has to be passed in the meeting of the board of directors of the company for approval on the closure of the bank account.

Mortgage of Property to Bank When a company applies to any bank for obtaining a loan from them, generally the bank will ask for security as against the loan amount. The company can mortgage any of its immovable properties viz. land, building, etc. in favor of the bank to secure the loan.
