A corporate resolution is a formal declaration made by a board of directors that officially records specific decisions that are material to a business. These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. This holds true for signing documents. By default, all members have authority to act on behalf of the LLC. An operating agreement can modify this default rule by expanding or limiting the authority of

persons involved with the LLC. It is common, for example, for an operating agreement to appoint nonmember managers to manage the LLC and grant them signing power. In the converse situation, an LLC might limit the authority of one or more of its members.
