The Tincher decision makes clear that Pennsylvania will continue to apply § 402A of the Restatement (Second) of Torts (Second Restatement) in products liability cases and that jurors, not the court, will decide the question of whether a product is in a defective condition. Plaintiffs may prove that a product is defective using either the consumer expectations test or the risk-utility test.

Currently, the Pennsylvania law of strict product liability is based on §402A of the Restatement (2d) of Torts. Under Pennsylvania law, a manufacture/supplier of a product is the guarantor of its safety. The manufacturer/supplier is liable for any harm that a defect in its product was a substantial factor in bringing about the harm.
