Memorandums of Association. A Memorandum of Association must be filed in order to incorporate a new company. It is a statement that the initial subscribers wish to form a company under the Companies Act 2006, have agreed to become members and, in the case of a company that is to have a share capital, to take at least one share each. The memorandum does

not contain any constitutional rules of the company and once the company has been incorporated, it cannot be amended.

MEMORANDUM AND ARTICLES OF ASSOCIATION

In short, the memorandum contains the names of all the subscribers (the people who were there at the founding point of the company e.g. initial shareholders) and the Articles of Association are a set of rules that govern how the company is run.

What are the Memorandum and Articles of Association?

A company's memorandum of association sets out the the company's structure and aims. These are the fundamental conditions upon which the company is incorporated upon. Section 22 (1) of the Companies Act provides that, among other things, the company memorandum has to state The name of the company
