International norms recognize that children have the right to freedom of opinion, of expression, and of association. If these rights are recognized for all children around the world, without exception, then most of them do not have the chance to benefit, and certainly do not even realize that they are benefiting from these freedoms.

In Indian constitution, the articles from 19 to 22 consist of Right to freedom.
