Summary. ASCs may not limit surveyor ability to observe patient care and surveyors are not required to sign documents or provide proof of vaccinations in order to observe a surgical procedure, and obtain the consent of the operating physician prior to observing a surgical procedure. Surveyors will obtain patient's consent and conduct themselves in a manner that protects patient safety and that does not interfere with the operating physician or procedure.

An ASC must be certified and approved to enter into a written agreement with CMS. Participation as an ASC is limited to any distinct entity that operates exclusively for the purpose of providing surgical services to patients not requiring hospitalization and in which the expected duration of services would not exceed 24 hours following an admission.
