At the end of *Black Boy*, Wright sits poised with pencil in hand, determined to "hurl words into this darkness and wait for an echo." Seventy-five years later, his words continue to reverberate. "To read *Black Boy* is to stare into the heart of darkness," John Edgar Wideman writes in his foreword. "Not the dark heart Conrad searched for in Congo jungles but the beating heart I bear." White Diaspora *Princeton University Press*

This is the first book to analyze our suburban literary tradition. Tracing the suburb's emergence as a crucial setting and subject of the twentieth-century American novel, Catherine Jurca identifies a decidedly masculine obsession with the suburban home and a

preoccupation with its alternative—the experience of spiritual and emotional dislocation that she terms "homelessness." In the process, she challenges representations of white suburbia as prostrated by its own privileges. In novels as disparate as *Tarzan* (written by Tarzana, California, real-estate developer Edgar Rice Burroughs), Richard Wright's *Native Son*, and recent fiction by John Updike and Richard Ford, Jurca finds an emphasis on the suburb under siege, a place where the fortunate tend to see themselves as powerless. From *Babbitt* to *Rabbit*, the suburban novel casts property owners living in communities of their choosing as dispossessed people. Material advantages become artifacts of oppression, and affluence is fraudulently identified as impoverishment. The fantasy of victimization reimagines white flight as a white diaspora. Extending innovative trends in the study of nineteenth-century American culture, Jurca's analysis suggests that self-pity has played a constitutive role in white middle-class identity in the twentieth century. It breaks new ground in literary history and cultural studies, while telling the story of one of our most revered and reviled locations: "the little suburban house at number one million and ten Volstead Avenue" that Edith Wharton warned would ruin American life and letters.

The Death-Bound-Subject *Duke University Press*

During the 1940s, in response to the charge that his writing was filled with violence, Richard Wright replied that the manner came from the matter, that the "relationship of the American Negro to the American scene [was] essentially violent," and that he could deny neither

the violence he had witnessed nor his own existence as a product of racial violence. Abdul R. JanMohamed provides extraordinary insight into Wright's position in this first study to explain the fundamental ideological and political functions of the threat of lynching in Wright's work and thought. JanMohamed argues that Wright's oeuvre is a systematic and thorough investigation of what he calls the death-bound-subject, the subject who is formed from infancy onward by the imminent threat of death. He shows that with each successive work, Wright delved further into the question of how living under a constant menace of physical violence affected his protagonists and how they might "free" themselves by overcoming their fear of death and redeploying death as the ground for their struggle. Drawing on psychoanalytic, Marxist, and phenomenological analyses, and on Orlando Patterson's notion of social death, JanMohamed develops comprehensive, insightful, and original close readings of Wright's major publications: his short-story collection *Uncle Tom's Children*; his novels *Native Son*, *The Outsider*, *Savage Holiday*, and *The Long Dream*; and his autobiography *Black Boy/American Hunger*. *The Death-Bound-Subject* is a stunning reevaluation of the work of a major twentieth-century American writer, but it is also much more. In demonstrating how deeply the threat of death is involved in the formation of black subjectivity, JanMohamed develops a methodology for understanding the presence of the death-bound-subject in African American literature and culture from the earliest slave narratives forward.

Black Writers, White Publishers Univ. Press of Mississippi

Jean Toomer's "Cane" was advertised as "a book about Negroes by a Negro," despite his request not to promote the book along such racial lines. Nella Larsen switched the title of her second novel from "Nig" to "Passing," because an editor felt the original title "might be too inflammatory." In order to publish his first novel as a Book-of-the-Month Club main selection Richard Wright deleted a scene in "Native Son" depicting Bigger Thomas masturbating. Toni Morrison changed the last word of "Beloved" at her editor's request and switched the title of "Paradise" from "War" to allay her publisher's marketing concerns. Although many editors place demands on their authors, these examples invite special scholarly attention given the power imbalance between white editors and publishers and African American authors. "Black Writers, White Publishers: Marketplace Politics in Twentieth-Century African American Literature" examines the complex negotiations behind the production of African American literature. In chapters on Larsen's "Passing," Ishmael Reed's "Mumbo Jumbo," Gwendolyn Brooks's "Children Coming Home," Morrison's "Oprah's Book Club" selections, and Ralph Ellison's "Juneteenth," John K. Young presents the first book-length application of editorial theory to African American literature. Focusing on the manuscripts, drafts, book covers, colophons, and advertisements that trace book production, Young expands upon the concept of socialized authorship and demonstrates how the study of publishing history and practice and African American literary criticism enrich each other. John K. Young is an associate professor of English at Marshall University. His work has appeared in journals such as "College

English," "African American Review," and "Critique."

Ever since Bessie Smith's powerful voice conspired with the "race records" industry to make her a star in the 1920s, African American writers have memorialized the sounds and theorized the politics of black women's singing. In *Black Resonance*, Emily J. Lordi analyzes writings by Richard Wright, Ralph Ellison, James Baldwin, Gayl Jones, and Nikki

Giovanni that engage such iconic singers as Bessie Smith, Billie Holiday, Mahalia Jackson, and Aretha Franklin. The Motif of "Blindness" in Richard Wright's 'Native Son' GRIN Verlag

Seminar paper from the year 2008 in the subject English - Literature, Works, grade: 2,7, [http://www.uni-jena.de/\(Institut für Anglistik/Amerikanistik\)](http://www.uni-jena.de/(Institut für Anglistik/Amerikanistik)), language: English, abstract: The motif of "blindness" is an idea that recurs many times in Richard Wright's masterpiece *Native Son*. Thus it has got a significant meaning to develop the novel's general theme. This motif, next to others (such as "whiteness"), supports a certain idea: Referring to James Nagel, it is "[...] operative throughout the novel [...]" and provides the impression of "[...] a lack of understanding and of a tendency to generalize individuals on the basis of race. It is both a rationalization for those who are looking and a disguise for those who are looked at." Almost all the characters, occurring in the novel, are "blind" in a figurative sense, which makes them prejudiced or apparently charitable not knowing what they are actually causing. They provoke hatred and are not able to see reality as it is. In fact, Bigger is considered to be a stereotype representing the whole black mass. Not until the end of *Native Son* ("But what I killed for, I am!" 429) does he realize his being an individual with particular needs and emotions. Conversely, he sees himself through the eyes of others, especially through those of the white people surrounding him. Obviously, "blindness" plays an important role in the novel. This seminar paper will deal with this motif that underlines the character's "lack of understanding", as Nagel would call it, and their tendency to consider an individual to be just an example of a whole mass, namely Bigger as the

stereotype of the whole black community. In that way, microcosm is turned to macrocosm with no respect to Bigger's individuality. For the following analysis, it is, at first, necessary to focus on the definition of the term "motif" to continue with the main part. The latter is planned to include the "blindness", either in a literal or figurative sense (or both), of certain characters. Therefore, Mary and Jan will be considered at first. Secondly, we look at Mr. and Mrs. Dalton to go on further with Boris Max, Bigger's lawyer in the trial of the third book. These figures are chosen because of their significance for the plot and Bigger's personal development. Furthermore, they represent the meaning of "blindness" and its effects, mentioned above, best. The protagonist Bigger himself will be the last character who will be analysed according to his "blindness" to end up in a brief conclusion.
