Your Other Employees Need You to Mediate a Conflict Resolution . Do not believe, for even a moment, that the only people who are affected by the conflict are the participants. Everyone in your office and every employee with whom the conflicting employees interact is affected by the stress.

Steps in Mediating Workplace Conflict Resolution

Staff have the right to file a formal grievance using the Dispute Resolution Process in order (1) to appeal any formal corrective action such as written warnings, final written

warnings, or terminations; or, (2) to appeal an employment decision that the staff member believes to be discrimination based upon his or her age, color, disability, gender, gender expression, gender identity, genetic information, national origin, race, religion, sex, sexual orientation, or veteran status.
