The Federal Rules of Civil Procedure (pdf) (eff. Dec. 1, 2019) govern civil proceedings in the United States district courts. Their purpose is "to secure the just, speedy, and inexpensive determination of every action and proceeding." Fed. R. Civ. P. 1. The rules were first adopted by order of the Supreme Court on December 20, 1937, transmitted to Congress on January 3, 1938, and effective September 16, 1938.

To be appointed as a judge at the Federal Court of Justice, an individual must, in addition, be 35 years of age or older. Once appointed, the presidium of Federal Court of Justice assigns the new judge to one or more panels. As judges for life, judges of the Federal Court of Justice must retire upon reaching the retirement age.

39 If a judge or referee of the Federal Court of Appeal or a Judge, prothonotary or referee of the Federal Court is for any reason unable to continue in a proceeding or to render a judgment that has been reserved, the Chief Justice of the court in question may order that the proceeding be reheard or retried, on any terms that the Chief Justice considers just.
