You must have a precise understanding of the facts, since facts determine the relevance of any legal points you make later. Fact identification and organisation is an important legal skill. If it helps, draw a quick diagram to explain the facts and the parties. (b) Accept as true those facts that are given.

Guidance on how to answer problem-style questions

Rules - Define the legal rules that are relevant to the question. Application - Apply the legal rules to the facts of the question (this is the hard part!). Conclusion - Tie things up, usually in the form of an advice to your hypothetical client. Always use your reading time wisely to PLAN YOUR ANSWER before writing.
