Resolving trade disputes is one of the core activities of the WTO. A dispute arises when a member government believes another member government is violating an agreement or a commitment that it has made in the WTO. The WTO has one of the most active international dispute settlement mechanisms in the world. Since 1995, 596 disputes have been brought to the WTO and over 350 rulings have been issued.

Dispute Settlement under the AfCFTA is governed by the Protocol for Rules and Procedures for Settlement of Dispute. The settlement of disputes under the AfCFTA will be administered in terms of this Protocol which is to a considerable extent based on the Dispute Settlement Understanding (DSU) of the World Trade Organization. The Protocol creates a Dispute Settlement Body (DSB) which will administer all issues relating to dispute settlement under the AfCFTA Agreement.

The Agreement African Continental Free Trade Area (AfCFTA), comprising of the Agreement, Protocol on Trade in Goods, Protocol on Trade in Service, Protocol on Rules and Procedures on the Settlement of Disputes was signed on 21st March 2018. To date, the AfCFTA has received fifty-two (52) signatures and eighteen (18) ratifications, out of the required twenty-two (22) ratifications for its entry into force.
