First, the commons of thought and expression is threatened by institutions of copyright, patent, and trade secret. Second, free speech concerns have been allowed to trump privacy interests in all but the most egregious of cases. Post-9/11, issues of national security have run headlong into individual rights to privacy and free speech concerns.
