Contract Law in the UK is legislated through the Sale and Supply of Goods Act (HMSO 1994), which provides for protection of the seller and the buyer. When Hobby Tech Ltd., agrees to purchase goods from a supplier, a contract comes into force.

In addition to the protection offered by the common law, there exists statutory protection from unfair terms in the form of the Unfair Contracts Terms Act 1977, and the Consumer Rights Act 2015. The Unfair Contract Terms Act 1977 applies only to businesses and does not apply to consumer contracts or consumer notices.

Unfair Contract Terms Act and Consumer Regulations

The provisions in Chapter 2 of Part 1 deal with the supply of goods in consumer contracts, and mainly serve to restate and consolidate the existing law by imposing certain implied terms and minimum standards to be met by the goods sold to consumers.

Modern law has moved away from the principle of caveat emptor by passing the laws for the protection of the buyer consumers and by the implication of implied terms in a contract of sale.
