redundancy pay come into force on 6 April 2020. Employers that dismiss employees for redundancy must pay those with two years' service an amount based on the employee's weekly pay, length of service and age. The weekly pay is subject to a maximum amount. This amount is £538 from 6 April 2020.

Discrimination. The Government has promised to implement a planned reform to provide priority access to redeployment opportunities for pregnant women and new parents in a redundancy situation. The new Employment Bill will include

provisions to implement these new rights.

New legal requirements for employment contracts. Employment contracts must be issued on or before the start of employment to new employees and new workers. Currently, a contract only needs to be issued to employees within the first two months of employment.
