Governing Law and Dispute Resolution Sample Clauses

A simple dispute resolution clause is a section of a contract that defines how settlements and disputes will be

handled in the event the contract goes south. One way in which parties can handle a dispute is to go through arbitration. Arbitration is an informal process where all parties will agree in writing to submit their disputes to impartial persons that have been authorized to try to resolve the particulars of the dispute, resulting in a final and binding agreement.

Sample DISPUTE RESOLUTION Contract Clauses. You can

prevent litigation and provide a forum to resolve disputes by providing first for mediation, and then for arbitration, if needed. Consider adding one of the following clauses into your next contract: MEDIATION: "All disputes arising out of this agreement shall be submitted to mediation in accordance with the procedures of Arts Arbitration and Mediation Services, a program of California Lawyers for the Arts."

General Mediation Sample Clause The parties may wish to require mediation before submitting their dispute to other resolution mechanisms. This can be accomplished by

including a mediation provision (which specifies that mediation shall last for at least a one-day session) in the remedies or dispute resolution section of the contract.

(leaving choice of process to parties) If a dispute arises out of, or in connection with this Contract, the parties agree to meet to pursue resolution through negotiation or other appropriate dispute resolution process before resorting to litigation.

DR Model Clauses and Agreements

Existing disputes. If a dispute has arisen, but there is no agreement between the parties to arbitrate, or if the parties wish to vary a dispute resolution clause to provide for LCIA arbitration, the following clause is recommended. Words/spaces in square brackets should be deleted/completed as appropriate. "A dispute having arisen between the parties

concerning [], the parties hereby agree that the dispute shall be referred to and finally resolved by arbitration under the LCIA Rules.

Mechanisms for appropriate dispute resolution should be considered when entering a contract. A dispute resolution clause specifying that alternative processes should be followed in the event of a dispute may assist in avoiding the cost and disruption of litigation, and provide the parties with a greater level of flexibility and control over the process.

But that purpose can oft be defeated, if the parties get caught in a dispute on the interpretation of the arbitration clause itself. Therefore, it is important to keep the arbitration clause simple, only incorporating essential aspects.
