In a 2004 study published in the American Journal of Drug and Alcohol Abuse, injection drug users claimed that wanting to conceal their addiction from a spouse was the most common reason they avoided treatment. A 2014 Johns Hopkins study found Americans are more likely to have negative opinions of people with substance use disorders than other mental illnesses.
