The Pensions Ombudsman Powers Procedures

The Pensions Ombudsman: Powers, Procedures and Decisions ...

The power to decide these matters rests with the Pension Protection Fund Ombudsman (and Deputy Pension Protection Fund Ombudsman) who are appointed by the Secretary of State for Work and Pensions. Only an Ombudsman can make a final and binding decision on a case, however under the legislation they can delegate any other responsibilities to other people in the organisation.

What we do | The Pensions Ombudsman

A description of the work of the Pensions Ombudsman (TPO) When someone has tried to resolve a problem with their pension and isn't satisfied with the outcome, they can ask us to help. We are an independent organisation set up by law to investigate complaints about pension administration.

Jurisdiction Adjudicator | The Pensions Ombudsman

Contingent plans have been put into place in the event that the Pensions Ombudsman is unavailable to make a Determination. The Legal Director, Claire Ryan, has been given authority to act as the Deputy Pensions Ombudsman and make Determinations if this were to occur. The situation will be kept under review over the coming year. The Ombudsman and Deputy Ombudsman are appointed by the Secretary of State for Work and Pensions.

What's involved? | The Pensions Ombudsman

The Pensions Ombudsman procedure is set out in sections 149

and 150 and the Personal and Occupational Pensions Schemes (Pensions Ombudsman) Procedure Rules 1995 (No. 1053) as amended. The Pensions Ombudsman will not deal with a dispute unless it has been through the Internal Dispute Resolution procedures (subject to limited exceptions in regulation 3).

If the Ombudsman's directions have not been followed, you can take action to enforce the Determination. We cannot help you to do this as we do not have the power to enforce the Ombudsman's Determinations. In England and Wales, Determinations are enforced through the County Court. The appropriate hearing centre is the one nearest to the ...

Submit a complaint | The Pensions Ombudsman

Making a complaint. If you have a complaint or dispute about your pension, we can help to sort it out. This may be a pension scheme provided by your employer (which might be an occupational pension scheme or a personal pension plan) or a pension you have set up yourself.

Making a complaint | The Pensions Ombudsman

Step 1: A decision is taken that affects benefits (a "first instance decision") Step 2 : An informal approach to resolving a disagreement about that decision Step 3 : The instigation of the formal, two stage IDRP (the internal "appeal") Step 4 : Application to the Pensions Ombudsman for a determination (the external "appeal")
