According to the Bureau of Labor Statistics, in 2016, the Focus Four Hazards—also called the Fatal Four—were responsible for

64% of all fatalities in the construction sector. (OSHA separately states that 90% of construction fatalities come from these four hazards.) Falls lead the group with 384 out of 991 total deaths (38.7%), followed by struck by object—93 deaths (9.4%); electrocutions—82 deaths (8.3%); and caught in between—72 deaths (7.3%).

Anything that could cause a worker to lose balance and result in a fall is considered a fall hazard. Falls

Struck-by hazards are one of the four most deadly hazards found on a construction site (the other three being falls, electrical and caught-in). Struck-by issues can come from falling, flying and swinging/slipping objects as well as from objects on the ground.

Four workers were struck by an exterior wall while attempting to lift it in place. Three of the workers received bruises and contusions. One of the workers received a fractured leg and was hospitalized. A construction inspector was crossing an equipment vehicle route at an interstate highway bridge construction site.
