Custody And Support Orders For

Child arrangements orders replace residence orders (deciding which parent a child should live with) and contact orders (covering what contact rights the non-resident parent has). An order usually lasts until the child is 16 or exceptionally 18 years old. Anyone with parental responsibility can apply to the court for a child arrangements order.

Enforcing Custody and Child Support Orders. Ideally, parents follow their custody orders (often called parenting plans) and child support orders to the letter. If they don't, they can face serious repercussions. You have three options for getting the other parent to comply with custody orders: work with the parent, go to court or call the police.

Enforcing a Child Custody or Support Order. While in an ideal world parents would comply with any custody or support order regarding their child, that does not always occur. It can be frustrating to try to co-parent with a person who is unwilling to abide by the rules set forth by the court. Additionally, a refusal to comply with the obligations set forth in custody and support orders will likely create confusion and turmoil in the life of the child the orders are intended to protect.

Enforcing a Child Custody or Support Order

When support or custody have been set on a temporary basis (often referred to by the Latin phrase "pendente lite," which means "during the proceeding"), the Court has the authority to modify its order at any time "for good cause shown and in the service of the ultimate goal of substantial justice." Many courts will allow parents to file a consent order setting forth an agreement regarding custody and support of a child, provided the agreement is determined to be in the child's best interest. Factors considered in determining whether an agreement is in a child's best interest include whether the agreement is harmful or beneficial to the child's emotional and physical health and well-being.

When a judge makes a decision regarding child custody and visitation, the decision becomes an official court order. A child custody order is enforceable by the court, as well as by law enforcement should it become necessary. In addition to custody orders, the judge will probably also make child support orders. Keep in mind that a child support order is separate from child custody and visitation, so you cannot refuse to let the other parent see the children just because he or she is not making the child support payments that the court ordered.
