In Florida, you could receive one of four types of eviction notices, depending on the reason for the eviction: Three-day notice to pay rent or quit: With this notice, you have three days to pay rent or move out of the rental unit (see Fla. Stat. Ann. § 83.56(3)).

To evict a tenant in Florida, a landlord must follow the procedure governed by Chapter 83 of the Florida Statutes. Failure to follow the proper procedure could lead to an eviction suit being dismissed, or result in the tenant being awarded fees and costs or even damages. Common grounds to terminate a tenancy are when a tenant fails to pay rent, violates the rental agreement, or violates local, state, or federal law.

Filing A Motion To Stay The Summary Eviction Order. A Motion to Stay (Delay) Order for Summary Eviction allows the tenant to ask the court to "stay" (pause) a summary eviction and grant the tenant up to ten more days to move. (NRS 70.010(2); JCRCP 110.) A tenant can file a motion to stay at any time after an eviction notice is served. (JCRCP 110.)

Evictions for Nonpayment of Rent A landlord who evicts a tenant

for not paying rent in Florida must give the tenant a three-day notice to vacate for failure to pay rent, or a notice similarly named. This notice gives the tenant three days to either pay the rent or leave the rental unit.

If you have valid grounds to stay the Writ, you can file an Emergency Motion with the Court. It is then up to the Court to determine whether they will grant it and provide you with a hearing. If the Tenant is the prevailing party at the hearing, the Writ may be stayed (delayed). It is recommended that you consult with a Florida Eviction attorney.

That means the sheriff or constable will lock you out within (as distinct from after) 24 hours.
