THREE DAY NOTICE - Sarasota Clerk of the Circuit

The Court may consider the proof of service of the Notice when making a ruling on a residential eviction. You may serve the Three Day Notice by sending it through certified, return receipt mail. The return receipt must be signed by the tenant. Three Day Notice may also be served by a private process server, who will supply the Affidavit of Service.

The three day notice notification is a way for property managers to legally get rid of occupants who do not pay rent, or are consistently late with rent payments. It is also within the right of property managers to evict tenants who mistreat their property if upon inspection the property manager thinks the tenant has kept the property in an unacceptable manner.

Depending on the type of eviction (eg, holdover, failure to pay rent, non-compliance with lease, etc) the contents of the notice will be slightly different, but basically the idea is to notify the tenant that you are seeking to evict them and that they have 3 days to comply with the notice or a suit for eviction will be filed. Sign the notice, include the date, and also include your mailing address so the tenant can send a response.

The three (3) business days excludes Saturday, Sunday and observed legal holidays, per Florida Statute 683.01. Do not count the date the notice was given. Allow three (3) complete business days to

elapse before filing the lawsuit.
