al., 2009; NRC, 2008) have proposed a set of critical issues to be considered in the setup, design and management of participatory processes.

Proponents of public participation argue that those who must live with the outcome of an environmental decision should have some influence on it. Critics maintain that public participation slows decision making and can lower its quality by including people unfamiliar with the science involved.

Public Participation in Environmental Assessment and ...

Reflecting increased attention to the importance of the public's role in

environmental decision-making, the National Research Council (NRC) recently concluded that public involvement "is critical to ensure that all relevant information is included, that it is synthesized in a way that addresses parties' concerns, and that those who may be affected by a risk decision are sufficiently well informed and involved to participate meaningfully in the decision" (NRC, 1996).

Public Participation in Environmental Decisions: An ...

The Convention, which set out minimum requirements for public participation in various categories of environmental decision-making, calls upon signatory states to "guarantee the rights of access to information, public participation in

decision-making, and access to justice in environmental matters in accordance with the provisions of this Convention" (UNECE, 1998).

Public participation in environmental impact assessment

...

The Aarhus Convention and its Protocol on PRTRs empower people with the rights to access information, participate in decision-making in environmental matters and to seek justice. They are the only legally binding global instruments on environmental democracy.
