Qualified NPPs may bill a Subsequent Nursing Facility Care code, even if their service is provided before the physician’s initial visit. The documentation and diagnoses codes associated with the service need to support the medical necessity of such a service.

Answer These Professional SNF and NF ... - Medical Billing

A home visit is when a physician provides evaluation and management (E/M) services in a patient’s home. From January 2013 through December 2015, Medicare provided \$718 million in payments for physician home visits. Physicians are required to document the medical necessity of a home visit in lieu of an office or outpatient visit.
