Long Term Care Documentation Requirements

Documentation in the long-term setting is regulated by Federal regulation (FS14). Documentation should be complete, accurate, readily accessible and systematically organized. The admission assessments are lengthy but are important as these assessments create a picture of the resident's overall

condition.

An individualized plan of care for each resident accounts for the person's specific chronic medical needs, which are part of the individual's self and care needs. The documentation should demonstrate that the care professionals have recognized the impact of the chronic medical condition (s) on the resident's life.

The Importance of Documentation in Long-Term Care for ...

Long-term Care Documentation Requirements Although documentation requirements vary according to the payer, typically they must include a physician's order*, followed by a certification for the therapy plan that should include medical diagnosis, SLP diagnosis and treatment plan, and frequency and duration of treatment.

Getting Started in Long-Term Care

In addition to the SOM, other regulatory documents, such as the Resident Assessment Instrument (RAI), provide guidance to providers and suppliers on minimum wound documentation and reporting requirements in long term care. As such, it is important to be aware of these various documents and comply with the directions for each.^{1,3}
