Professional Engineering Experience

In order to constitute qualifying experience, the experience must meet a number of criteria. First, the experience should be from a major branch of engineering in which the candidate claims proficiency. Second, the experience must be supervised. That is, it must take place under the ultimate responsibility of one or more qualified engineers.

Demonstrating Qualifying Engineering Experience For ...

EITs generally need at least four years of work experience before becoming licensed as Professional Engineers (PEs). Work experience varies based on occupation and engineering discipline.

Engineering: Overview of How to Become a Professional Engineer

The Principles and Practice of Engineering (PE) exam tests for a minimum level of competency in a particular engineering discipline. It is designed for engineers who have gained a minimum of four years' post-college work experience in their chosen engineering discipline. For exam-specific information,

All states require that candidates complete four years of qualifying engineering experience, typically under the supervision of a professional engineer. To become licensed, engineers must complete a four-year college degree, work under a Professional Engineer for at least four years, pass two intensive competency exams and earn a license

from their state's licensure board. Then, to retain their licenses, PEs must continually maintain and improve their skills throughout their careers.

What is a PE? - National Society of Professional Engineers

Professional licensure protects the public by enforcing standards that restrict practice to qualified individuals who have met specific qualifications in education, work experience, and exams. In the United States, licensure for the engineering and surveying professions is regulated by state.

NCEES professional licensure

A "person licensed" is an individual that has qualified by education, experience and examination, and has been issued a New York State professional engineering license or land surveying license by the State Education Department.

National Society of Professional Engineers

The Board may grant toward experience requirements for registration as an engineer one (1) year of credit for graduation with a master's degree (or higher) in engineering from an approved curriculum or up to one (1) year of qualified experience obtained in an established cooperative education program, which is carried out within the framework of an approved engineering curriculum, and which has been approved by the Board.

Engineers - Tennessee

Professional Engineer Applicant apply directly to NCEES to take the PE exam. Only those applicants that have met the education requirements and have passed the FE exam may sit for the PE exam prior to having gained the required experience. Then, upon gaining the required experience, apply for the PE license.

Professional Engineer | NCBELS

Ontario law requires that you have four years of engineering work experience before you can obtain your professional engineering licence. At least one year of your experience must be obtained in a Canadian jurisdiction. This ensures that you have sufficient exposure to Canadian engineering codes, legislation, technical standards and regulations.
