STATE OF MICHIGAN COURT OF APPEALS

Household goods, such as utensils, furniture, books, jewelry, and appliances, valued up to \$600 per item and \$3,825 in total. The exemption is available under Section 600.5451 (1) (c). All clothing is exempt under Section 600.5451 (1) (a) (iii); however, this does not include furs.

Harmelin v Michigan, 501 US 957; 111 S Ct 2680; 115 L Ed2d 836 (1991). In *People v Bullock*, 440 Mich 15; 485 NW2d 866 (1992), the Michigan Supreme Court held that the Michigan Constitution prohibits cruel or unusual punishment while the Eighth Amendment to the US Constitution bars only punishment that is both cruel and unusual.
