For tax purposes, the general principle is that the tax treatment follows the accounting treatment because for most companies, most financial instruments will fall to be classed as loan relationships (under Part 5 CTA 2009), non-lending money debts (treated as loan relationships under Chapter 2 of Part 6 CTA 2009) or derivative contracts (under Part 7 CTA 2009).

Taxation of Forgivable Loans. The CECRA and the forgivable portion of CEBA are taxable when received (ITA s. 12 (1) (x)), but if and when repaid, are deductible when repaid (ITA s. 20 (1) (hh)). This means that the 25% (up to \$10,000) forgivable portion of CEBA and 100% of CECRA will be taxable in 2020 . If any of the forgivable portion is repaid, because requirements were not met, then this can be deducted in the taxation year when the amount is repaid.

September 8, 2020. Paycheck Protection Program (PPP) loan forgiveness and its tax and financial reporting implications are steeped in uncertainty. The key challenges are the timing of income recognition and deductibility of expenses, among other tax and reporting questions.

There are special tax rules to deal with the treatment of one-off transitional adjustments on financial instruments which fall within either the 'loan relationship' or 'derivative contract' rules on transition from one basis of accounting to another.

Tax considerations from the introduction of IFRS 9 - BDO

The calculation of tax is as similar as the calculation of individuals less than 60 years old (example above).
