The jus cogens (from the Latin “biding law”, an imperative norm) concerns principles of law considered universal and superior, and which must constitute the bases of the imperative norms of general international law. This concept is similar to, but not totally consistent with, that of customary international law, which presupposes recognition and general effective application.

International law ascribes to the conferral of a jus cogens status on a norm a particular legal significance. Bluntly put, jus cogens norms have legal consequences that norms of ordinary international law do not. International lawyers have a great many different ideas of what these legal consequences are more precisely.

The notion of jus cogens in international law encompasses the notion of peremptory norms in international law.¹In this regard, a view has been formed that certain overriding principles of international law exist which form "a body of jus cogens."²These principles are those from which it is accepted that no State may derogate by way of treaty.

Jus cogens, the literal meaning of which is "compelling law," is the technical

term given to those norms of general international law that are argued as hierarchically superior.¹These are, in fact, a set of rules, which are peremptory in nature and from which no derogation is allowed under any circumstances.

It designates norms from which no derogation is permitted by way of particular agreements. It stems from the idea already known in Roman law that certain legal rules cannot be contracted out, given the fundamental values they uphold. Most states and authors agree that jus cogens exists in international law. Opinions diverge however as to its exact content, sources, means of identification, and application, as well as to its precise effects and role within the international legal order.

Jus cogens, also known as the peremptory norm, is a fundamental and overriding principle of international law. It is a Latin phrase that translates to 'compelling law'. It is absolute in nature which means that there can be no defense for the commission of any act that is prohibited by jus cogens.

Concept of Doctrine of Jus Cogens under International Law

Speaking of fundamental rules of international law, we can list three categories considered as jus cogens, specifically prohibition of the threat or use of force under UN Charter, fundamental human rights, and international humanitarian law, as confirmed in Article 50 of ILC Articles on State Responsibility.

There is near-universal agreement for the existence of the category of jus cogens norms, and its existence is memorialized in Article 53 of the Vienna Convention on the Law of Treaties (VCLT): “ [A] treaty is void if, at the time of its conclusion, it conflicts with a peremptory norm of general international law.”
