Trusts are used often in financial planning, particularly when planning to reduce Inheritance Tax, save money for children or provide for the vulnerable. A trust is created when a person (the settlor) places money or assets in the hands of trustees to hold for the benefit of the beneficiaries.

Investment trusts, unlike unit trusts, can borrow money to buy shares, which is known as gearing. This extra buying potential can produce gains in rising markets but also accentuate losses in falling markets. Depending upon the specifics of the trust, the trustee can either manage the money themselves or outsource the investment of the money in the trust to a registered investment advisor. If you are establishing a trust, with the intent of using it to grow in value, you might consider provisions requiring a licensed investment professional if you don't believe your trustee can fulfill this portion of their duties.
